 - ➔ **Candidates who have appeared for the final year exam in April of the current year are requested to submit their final year mark sheet within seven working days from the date of declaration of Result of the Final year of the Graduation by the University of Mumbai**
 - ➔ NOC certificate is required from current Employer.
 - ➔ Admission will be on the basis of academic merit, work experience and personal interview.
 - ➔ Seats will be reserved as per University rules, which may be amended from time to time. A copy of the required relevant certificate must accompany all forms of students belonging to reserved categories.
 - ➔ Student from outside Mumbai University will be admitted provisionally after verifying original documents of graduation. As per Mumbai University rules, the admission will be confirmed on submission of verification report from respective university.
 - ➔ Separate merit lists will be prepared for general and reserved category students as per relevant rules. Category-wise merit list of all examinees will be computed, and inform to the candidates by email only.
 - ➔ The 1979 batch of GIC Direct Recruit Officers (GIC DRO) has instituted a cash prize of ₹15,000/- to the best performing candidate of III-PGDHI.
 - ➔ A maximum of **40** students will be admitted on the basis of the merit lists so prepared.
- i. Shortlisted candidates shall have to attend a personal interview at subsequent date at their own cost.
 - ii. Selected candidates have to pay the course fees by Demand Draft (In favour of Insurance Institute of India payable at Mumbai) at the time of admission.
 - iii. Students graduated from outside University of Mumbai shall be required to submit migration certificate along with original certificates of graduation.
