The Programme

The Ph. D. Program is offered on part-time basis. The Ph.D. will be awarded by the University of Mumbai in the subject "**Business Management**" under Commerce Department. It comprises initial 6-month course work if the candidate has not completed M. Phil.

The Eligibility

The candidate must have Masters Degree or equivalent in relevant subject with 55% from recognized University/ Institute and qualified in PET of University of Mumbai or NET/ SET/ JRF or as specified by University of Mumbai in its ordinance. OBC/SC/ST and any other special category will have relaxation applicable as per the University of Mumbai rules.

Fellowship/ Scholarship

Students admitted for full time / part-time research would not be eligible for any fellowship/ scholarship/ grant/ financial support. However under Ph.D. programme, there is no embargo for III research students in seeking/ availing financial assistance from their employers or any other sources on merits, subject to the same being disclosed to III. Based on academic relevance and merits of the case, the management may solely at its discretion, consider granting financial assistance to researchers for attending/ presenting papers at seminars/ conferences and other academic activities relating to the research work.
