The importance of preventing, avoiding and eradicating frauds is being increasingly understood by the industry in recent years. However, the lack of a comprehensive and integrated approach to Insurance Fraud Management continues to be a concern. While fraud related courses are available in more developed markets, the absence of a comprehensive academic programme that can create a cadre of anti-fraud professionals has been cited as a reason for the Indian Insurance industry being increasingly victimized by fraud.



In this context, III has designed its **Certified Insurance Anti-Fraud Professional (CIAFP)** course in association with North American Training Group (NATG).
