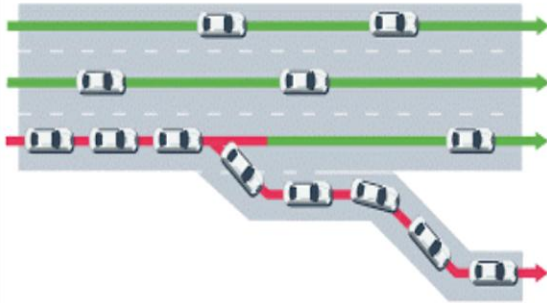




## Virtual Training Session on Emerging Trends in Motor Insurance Claims (CVT-ETMIC) 4<sup>th</sup> - 5<sup>th</sup> December, 2020



The Motor Insurance market has been changing during the last few years due to changes in the Motor Insurance Act, Motor Insurance related regulations by Insurance Regulator and the changes brought in by new technology.

Motor Insurance Claims are increasingly being assessed with the help of smart tools; and technology - from use of telematics, drones, artificial intelligence and the internet of things (IOT) - is now used extensively in claims assessment.

Insurers are using various simulation models to reconstruct the accident scene in order to understand the causes of accident and ways of avoiding it. This sector has been plagued with frauds of high proportions and insurers need to build internal capabilities to counter them.

The College of Insurance has designed a two-day programme for understanding how technology has been helping insurers in dealing with Motor claims more effectively and reducing fraud.

The programme is designed to enable participants to:

- ✓ Gain insight into the construction of modern cars and the anatomy of vehicles
- ✓ Understand the use of technology in handling Motor claims
- ✓ Appreciate the use of data analysis in managing claims situations better
