# Details of the course: Introduction, Eligibility Criteria and Structure



## Introduction

In India even with the annual premium growth rate of above 9% (2019-20) General Insurance penetration is about 0.9%(2019) of the GDP. The desired level is about 4%. Hence, there is a lot of space for further growth in General Insurance segment.

Average growth rate of the property segment is not impressive.

The reasons are many but absence of sufficient qualified manpower with adequate underwriting knowledge in the field of property Insurance is one of the key contributory factors.

Moreover, complexity in managing property insurance is far greater than that of other lines of business.

- participation, response and conduct during online class (internal evaluation)
- on attendance

2. Fire and Business Interruption Insurance
3. Engineering Insurance
4. Marine Cargo Insurance
5. Liability Insurance
6. Miscellaneous Insurance (related to property)
